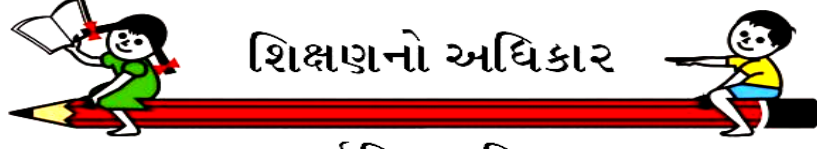

SECTION-I

INVITATION FOR BIDS (IFB)
Bid No.: SSA/IED/OH-HI/2014-15/01

- 1.1.State Project Director, Sarva Siksha Abhiyan, Gujarat invites Technical & Commercial Bids Rate Contract for Supply of Appliances to the OH & HI children by organizing assessment camp at block level.
- 1.2.A complete set of Bid Document can be downloaded by any interested eligible bidder from web site on the date & time shown in schedule of e-tendering.
- 1.3.Interested eligible Bidders may obtain further information from office of the State Project Director, during the office hours only.
- 1.4.Interested and eligible Bidders are required to submit bids online in two parts viz. Technical and Commercial. The first part i.e Technical bid should include the qualification criteria of the bidder and specimen of appliances. It should not contain any cost information what so ever. The second part i.e Commercial bid should contain the detailed rate offered for each item of Appliances to be supplied to the OH & HI children or OH children or HI children by organizing assessment camp at block level. This part i.e Commercial bid should be submitted online only. The Technical Bid should be accompanied by document fee & bid security and Specimen of Appliances for HI and OH Items as specified in schedule of e-tendering. The document fee & Bid Security should be in the form of Demand draft issued by any Nationalized Bank or banks approved by finance Department GR no. EMD/10/2013/655/DMO Dtd. 31/03/2014 in favour of State Project Director, SSA Mission, Gandhinagar & payable at Gandhinagar.
- 1.5.The Technical Bid will be opened on the specified date & time & specimen sample of all appliances demonstration in the presence of Bidders or their authorised representative who chooses to attend. In the event of the date specified for bid receipt and opening being declared as a government holiday the due date for submission and opening of bids will be the following working day at the appointed time.

SECTION-II
INSTRUCTIONS TO BIDDERS

1. Introduction

The State Project Director Gujarat Council of Elementary Education Gandhinagar invite bids for Supply of Appliances to the OH & HI children by organizing camp at block and district level.

Basic pre-qualification criteria for the Agency to participate in the bid process are as under:

- a) The bidding firm should be registered with local body or any approved Govt. organization.
- b) Should have a minimum total turnover of **Rs. 50.00 lac** in any one year during last two years for supply of appliances. **(2011-12 & 2012-13)**
- c) Bidding firm should submit proof for activity carried out for Welfare of disable child or evidence of supply for Appliances for disable child during last two years (2011-12 & 2012-13).
- d) Joint venture between any other companies is not allowed.

1.1 All bids must be accompanied by document fee, Bid security as specified, technical documents & specimen sample of appliances submitted on or before the prescribed date and time shown in schedule of e-tendering. Bids submitted without document fee, Bid security, technical documents & specimen sample will be summarily rejected.

2. Cost of bidding

2.1 The bidder shall bear all costs associated with the preparation and submission of its bid, and the Gujarat Council of Elementary Education, herein after referred to as “the Purchaser” will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

3. Content of bidding documents

The set of Bidding documents comprises the documents listed below:

4. The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all information required by the Bidding Documents or submission of a Bid not substantially responsive to the Bidding Documents in every respect will be at the Bidder's risk and may result in rejection of its Bid.

5. Amendment of Bidding Documents

- 5.1 At any time prior to the deadline for submission of bids, the Purchaser may, for any reason whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the Bidding Documents by amendment.
- 5.2 The amendment will be notified putting on web site & will be binding to all the bidders.
- 5.3 In order to allow prospective Bidders reasonable time in which to take the amendment into account in submission of their bid, the Purchaser may, at its discretion, extend the deadline for the submission of bids.

6. Language of Bid

- 6.1 All documents relating to the bid shall be in the English/Gujarati/Hindi language only.

7. Documents Comprising the Bid

The Bid prepared by the Bidder shall be online submitted in '**Two parts**' comprising the following components:

- 7.1 **First part** shall contain **Technical Bid** Comprising of:

7.1.1 Bid form as per Table I.

7.1.2 **Technical Proposal,**

The Technical Bid shall include the attested copies of the following documents to demonstrate that the bidder has the Financial & Technical capability necessary to perform the contract and meet the criteria outlined in the qualification requirements:

- i. Attested copies showing the legal status, place of registration and principal place of business of the firm.

- ii. Attested copies of documents showing that the firm had minimum total turnover of **Rs 50.00 lac** in any one year during past two financial years for supply of similar nature of appliances. (2011-2012 and 2012-13)
 - iii. Attested copies of Audited financial Statements for the last two years i.e., 2011-2012 and 2012-13.
 - iv. Documents showing the proof of registration with local body or any approved Govt. organization.
 - v. Bidding firm should submit proof for activity carried out for Welfare of disable child Or evidence of supply for Appliances for disable child during last two years (2011-12 & 2012-13).
- 7.1.3 The Bidders should display the appliances. The sticker showing the name of firm shall be pasted on all the appliances to identify the firm whose specimen is displayed and must be submitted with technical Bid.
- 7.1.4 The first part i.e Technical Bid should not contain any cost information what so ever.
- 7.1.5 Document fee in the form of DD drawn on Nationalized Bank or banks approved by finance Department GR no. EMD/10/2013/655/DMO Dtd. 31/03/2014 in favour of State Project Director, SSA, Gandhinagar payable at Gandhinagar shall be furnished in physical form along with technical bid.
- 7.1.6 **Bid Security** in the form of D.D drawn on Nationalized Bank or banks approved by finance Department GR no. EMD/10/2013/655/DMO Dtd. 31/03/2014 in favour of State Project Director, SSA, Gujarat, payable at Gandhinagar as per the instruction furnished under clause-11 shall also be furnished in physical form along with technical bid.
- 7.2 **The Second part** shall contain the **Commercial Bid** and should contain the detailed rate offered for each OH/HI Appliances to be supplied; Rates should be specified as per the Price schedule provided in Table-V. This part shall be submitted online only.
- 8. Price Quote in Commercial Bid**
- 8.1. **Prices shall be indicated separately in the schedule as per the format.**
- 8.2. Prices quoted by the Bidder shall be inclusive of all the taxes & shall be fixed during the bidder's performance of the contract and not subject to variation on any account. Moreover Expenses for Transportation, Lodging and Boarding etc. of Experts are inclusive and to be borne by Supplier however Cost of Travelling etc of the disable child and his or her parents shall be borne by Gujarat Council of Elementary

Education. Any bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.

9. The Bidder must submit all the documents listed under Clause 7 and all the sub-clauses thereof, along with the Bid form as per Table I in physical form along with draft of document fee and Bid Security and Samples as per date & time shown in schedule of e-tendering. Bid submitted without document fee, Bid security and specimen sample will be treated as a non responsive.

10. Successful bidder is bound to complete all the assessment camp at Block level within Three months from the date of work order and supply the required appliances for OH and HI within 45 days from the date of the assessment Camp.

11. Bid Security

11.1 The Bidder shall furnish, as part of its Bid, Bid security of **Rs.3,00,000/- (Rupees Three lacs only)**.

11.2 The Bid security is required to protect the purchaser against risk of Bidder's conduct, which would warrant the forfeiture of security.

11.3 The Bid security shall be in Indian Rupees and shall be in the following form.

A D.D issued by a Nationalised Bank or banks approved by finance Department GR no. EMD/10/2013/655/DMO Dtd. 31/03/2014 in favour of State Project Director SSA, Gujarat payable at Gandhinagar.

11.4 Any Bid not secured in accordance with Clause 11.1, 11.2 and 11.3 above will be rejected by the Purchaser as non-responsive.

11.5 Unsuccessful Bidder's bid security will be discharged/returned as promptly as possible but not later than 30 days after the expiration of the period of Bid validity prescribed by the purchaser.

11.6 The successful Bidder's Bid security may be adjusted towards performance security to be furnished by the Bidder before signing the contract agreement.

11.7 The Bid security may be forfeited:

- (a) If a Bidder withdraws his Bid during the period of Bid validity specified by the Bidder on the Bid Form; or
- (b) In case of a successful Bidder, if the Bidder fails
 - (i) To sign the contract agreement; and
 - (ii) To furnish performance security.

12. Period of Validity of Bids

- 12.1 Bids shall remain valid for 90 days after the date of opening of commercial bid. A bid valid for a shorter period shall be rejected by the Purchaser as non-responsive.
- 12.2 In exceptional circumstances, the Purchaser may solicit the Bidder's consent to an extension of the period of validity. The bid security provided under Clause 11 shall also be suitably extended. A Bidder may refuse the request without forfeiting its bid security. A Bidder granting the request will not be required nor permitted to modify its bid.

13. Submission of Bids

- 13.1 The first part i.e Technical bid shall be submitted in physical form to the purchaser at the following address as below :

- 13.2 The physical document of Technical bid shall indicate the name and address of the Bidder to enable the purchaser to return the same unopened to the bidders in case it is declared late.
- 13.3 The Bids and all appliances must be delivered to the address as indicated in clause 13.1 at the above. Bids sent by Telex or Fax or E-mail will be rejected.
- 13.4 All appliances shall be sent to the State Project office at the time of submission of Bids. The Bids without the sample of all appliances will be kept unopened and will be returned to the bidder.

14. Deadline for Submission of Bids

- 14.1 Bids must be online submitted as per schedule of e-tendering specified in the Invitation for Bids (Section I).
- 14.2 The document in physical form should reach the purchaser on or before the date & time shown in schedule of e-tendering.
- 14.3 The Purchaser may, at its discretion, extend the deadline for submission of bids by amending the Bid Documents in which case all rights and obligations of the Purchaser and Bidders previously subject to the original deadline will thereafter be subject to the deadline as extended.

15. Late Bids

- 15.1 Any Bid received by the Purchaser after the deadline for submission of bids prescribed by the Purchaser pursuant to clause 14, will be rejected and/or returned unopened to the Bidder. The purchaser will not be held responsible for the postal delay if any.

16. Withdrawal of Bids

- 16.1 No bid may be withdrawn in the interval between the deadline for submission of bids and the expiration of the period of bid validity specified by the Bidder on the Bid Form. Withdrawal of a bid during this interval may result in the Bidder's forfeiture of its bid security, pursuant to ITB Clause 11.7

17. Opening of Bids by the purchaser.

- 17.1 The Purchaser will open the **FIRST part i.e Technical bid** and verify the specimen sample in the presence of Bidder or their authorised representatives who choose to attend, on the date & time shown in schedule of e-tendering at the address as shown below.

State Project Office, SSA, GCEE, Sector-17, Gandhinagar

The Bidders representatives who are present shall sign a register evidencing their attendance. In the event of the specified date of Bid opening being declared a holiday for the Purchaser, the Bids shall be opened at the appointed time, date and location on the next working day.

- 17.2 The date on which SECOND PART i.e Commercial Bid would be opened will be intimated to the qualified bidders by the Purchaser either through fax or through letter.**

- 17.3 The Bidders Names, Bid Withdrawals and the presence or absence of the requisite Bid security and such other details as the Purchaser, at its discretion, may consider appropriate will be announced at the time of opening of Technical bid. **No Bid shall be rejected at bid opening, except late bids and bid without document fee & bid security & specimen sample of all appliances which shall be returned unopened to the bidder pursuant to Clause 13 & 15.**

- 17.4** The Second part containing the Commercial Bid will be opened only for the Technically Qualified Bidder pursuant to clause 20.4. **The Second part i.e commercial bid of Bidders, who have not qualified in the technical evaluation will not be opened under any circumstances.**

- 17.5 Bids that are not opened and read out at bid opening shall not be considered further for evaluation, irrespective of the circumstances. Withdrawn bids will be returned unopened to the bidders.

- 17.6 The Purchaser will prepare minutes of the Bid opening.

18. Clarification of Bids

- 18.1 During evaluation of Bids, the purchaser may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response thereof shall be in writing.

19. Preliminary Examination

- 19.1 The Purchaser will examine the Bids to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed, and whether the bids are generally in order.
- 19.2 Prior to the detailed evaluation, the Purchaser will determine the substantial responsiveness of each bid to the Bidding Documents. For purposes of these Clauses, a substantially responsive bid is one, which conforms to all the terms and conditions of the Bidding Documents without material deviations. Deviations from or objections or reservations to critical provisions such as those concerning Performance Security, Warranty, Applicable Law and taxes and duties will be deemed to be a material deviation. **The purchaser's determination of the responsiveness of a Bid will be based on the contents of the bid itself without recourse to extrinsic evidence.**
- 19.3 If a bid is not substantially responsive, it will be rejected by the Purchaser and may not subsequently be made responsive by the Bidder by correction of the non-conformity or through clarifications. Clause 18.1 will not be applicable in case of a non-responsive bid.

20. Evaluation and Comparison of Bids

- 20.1 The Purchaser will evaluate and compare the Bids, previously determined to be substantially responsive, pursuant to clause 19.2 above.
- 20.2 The Purchaser will evaluate the substantially responsive Technical Bids in pursuant of the Qualification Criteria listed under Section V. The Committee, on their discretion, may inspect the premises of the bidder for evaluation their capability with reference to physical infrastructure available and other technical capabilities etc. if found necessary.
- 20.3 The Team of Expert will also evaluate the quality of specimen sample of all appliances demonstrated by the Bidder. Failure to demonstrate the specimen sample will entail disqualification of the bidder.
- 20.4 Deleted.

- 20.6 Deleted
- 20.7 The purchaser reserves the right to negotiate with responsive bidder and spilt the area among the bidders if required.

21. Acceptance or Rejection of Bids

- 21.1 The State Project Director, SSA, GCEE, Gujarat reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability or any obligation to inform the affected bidder or bidders of the grounds for the said action.
- 21.2 Any Bid with incomplete information is liable for rejection.
- 21.3 For each category of pre qualification criteria, the documentary evidence is to be produced duly attested by the Bidder, serially numbered and enclosed with the Bids. If the documentary proof is not enclosed for any/all criteria the Bid is liable for rejection. The information of turnover shall be certified by the chartered accountant.
- 21.4 If any information given by the bidder is found to be false /fictitious, the bidders will be debarred for 3 years from participating in any other tenders of GCEE.

22. Award of Contract

- 22.1 Subject to ITB clause 21, the Purchaser will award the contract to the successful Bidder whose bid has been determined to be substantially responsive, has been evaluated to be technically competent by the purchaser.

Award of contract will be for the period of 1 year but may be extended for next year with the consent of either party.

- 22.2 Deleted.

23. Notification of Award

- 23.1 Prior to the expiration of the period of bid validity, the Purchaser will notify the successful bidder in writing by registered letter or by fax that its bid has been accepted. The notification of award will constitute the formation of the Contract.
- 23.2 Upon the successful Bidder's signing of contract and furnishing of performance security, pursuant to ITB clause 24 & 25, the Purchaser will promptly notify each unsuccessful Bidder and will discharge its bid security, pursuant to clause 11.5

24. Signing of Contract

- 24.1. At the time as the Purchaser notifies the successful bidder that its bid has been accepted, the Purchaser will send the bidder the Contract Form, incorporating all agreement between the parties.

- 24.2. Within 7 (Seven) days of receipt of the Contract Form, the successful Bidder shall sign and date the Contract and return it to the Purchaser. Any incidental expenses of execution of agreement shall be borne by the successful Bidder(s). Hereafter the successful Bidder shall be referred to as “Contractor”.

25. Performance Security

- 25.1. The Contractor will be required to furnish Performance Security amounting to 5% of the contract value in accordance with the Conditions of Contract in the form of D.D. of nationalized bank or banks approved by finance Department GR no. EMD/10/2013/655/DMO Dtd. 31/03/2014 drawn in favour of the State Project Director, SSA Mission, Gujarat payable at Gandhinagar within 7 (seven) days of receipt of the notification of award of contract. The Performance Security is to be furnished along with the contract agreement duly signed by the Contractor.
- 25.2. The rates quoted by the bidder if found seriously unbalanced the employer shall ask for payment of additional performance security to protect the employers against financial loss.
- 25.3. If the Contractor fails to furnish the Performance Security in the format specified above within 7 (Seven) days and sign the contract agreement, as specified in clause 11.7, the Bid security furnished by such bidder will be forfeited.
- 25.4. The performance security furnished by the successful Bidder in respect of his/her bid will be returned to him/her at the end of 13 months from the date of Work order subject to the satisfactory performance of the contractual obligations.
- 25.5. If the successful Bidder after signing the contract agreement fails to perform any contractual obligation, the Performance Security furnished by the Contractor will be forfeited.

26. Failure of the successful bidder to comply with the requirement of Clause 24.2 and 25.1 shall constitute grounds for the annulment of the award and forfeiture of the Bid security, in which event the Purchaser may make the award to the next lowest evaluated bidder or call for new bids.

27. The Contractor shall not assign or make over the contract, the benefit or burden thereof to any other person or persons or body corporate. No under letting or subletting to any persons or body corporate for the execution of the contract or any other part thereof is permitted.

28. Penalty and Termination for non-fulfilment of Contract

- 28.1. If the contracted assignment is not completed in full within the period as stipulated in the Contract Agreement, a penalty at the rate of 0.5% of the value of remaining quantity will be levied per week from the date of expiry of the stipulated period. The total amount of penalty shall not exceed 10% of the contract value. The Contract may be terminated at the discretion of the Purchaser and at the risk and cost of the Contractor.
- 28.2. In the eventuality of termination for non-fulfilment of the contractual obligations, the Performance Security furnished by the Contractor will stand forfeited.

29. Payment Terms:

Payment will be made by State Project Office Gandhinagar on receipt of certificate as under:

- Certificate as prescribed by the IED state coordinator for Assessment camp should be jointly signed by concerned BRC and District IED Coordinator and counter signed by IED State coordinator attached with photographs of CWSN child to whom OH / HI appliances have been provided
- Certificate as prescribed by the IED state coordinator for supply of OH/HI appliances, should be jointly signed by concerned BRC and District IED Coordinator and counter signed by IED State coordinator attached with photographs of CWSN child to whom OH / HI appliances have been provided

29.1 Bidder may raise payment claim with original Invoice on Block wise basis also

30. State Project Director, SSA reserve the right to reject any or all bid without assigning any reason thereof.

SECTION-III**DESCRIPTION, SCOPE OF CONTRACT, SPECIFICATIONS & DRAWING****A. Specification of O.H. Appliances**

Sr. No.	Name of O.H. Appliances	Specification
1	ASH BRACE	(Anterior Sternum Holder brace) is recommended for patients having spinal injuries like PCD of spinal vertebrae, Fracture in spine and Congenital spinal deformity. It is a supporting brace fabricated from HDPE sheets with adjustable metallic strips and soft rubber / Leather linings and is made as per body measurements.
2	ABDOMINAL BINDER	Recommended to provide support for abdominal bulge as well as post surgery. It is fabricated from cloth and elastic alongwith Velcro fittings and is available in standard dimensions based upon body measurements.
3	LS ORHTOSIS	Recommended for lumbar spondylosis, lumbago etc and is fabricated from cloth, elastic and Velcro fittings based upon body measurements.
4	LS SPINAL	Recommended to provide support for lumbar vertebrae, compress fracture of lumbar vertebrae etc. It is fabricated from HDPE sheet frame with soft linings.
5	TAYLOR SPINAL BRACE	Recommended to provide support for patients suffering from lumbar tuberculosis, thoracic spine fracture in thoracic vertebrae and Kyphosis. It is fabricated from plastic supports, aluminium strips, soft rubber / leather linings with Velcro fittings.
6	MOULDED JACKET	This is a support fabricated from HDPE sheets with soft rubber lining and Velcro fittings. It is recommended for mild scoliosis of spine, tuberculosis of vertebrae, humps and Kyphosis.
7	MILWAUKEE SPINAL O/S	This is a support fabricated from metallic strips with HDPE supports and Velcro fixing belts. It is recommended for patients suffering from acute scoliosis of spine.
8	MOULDED CERVICAL O/S	This is recommended for cervical spondylosis and is fabricated from soft rubber sheets, lining and Velcro fixing.
9	FOUR POST COLLAR	This provides support for patients suffering from fracture or compression of cervical vertebrae and prevents cervical spine movement. It is fabricated from adjustable metallic round bars, plastic support and leather with soft linings and Velcro fixing.
10	PHILADELPHIA COLLAR O/S	This support is fabricated from moulded plastic and Velcro fittings and is recommended for patients having mild fracture in cervical vertebrae & compression in cervical spine.
11	SOMI BRACE	This support is fabricated from HDPE sheets with metallic supports, soft rubber sheet linings and Velcro fittings and is recommended for patients with quadriplegia, fracture in cervical vertebrae.
12	CLAVICEL O/S	It is fabricated from a plastic ring with padding and Velcro fittings and recommended for patients with clavicle bone fracture.

Sr. No.	Name of O.H. Appliances	Specification
13	UPPER LIMB PROSTHOSIS (SUPPORTING SPLINT)	This is fabricated from HDPE sheet with soft rubber linings and Velcro fittings to provide supports for the upper limb in case for humerus bone fracture. This would also include other types of dynamic splints / cock – up static splints.
14	ARTICIAL HAND (ABOVE ELBOW)	This is a mechanical artificial hand fabricated from Alimco kit with HDPE pipe socket fittings for patients having no hand from above the elbow.
15	ARTIFICIAL HAND (BELOW ELBOW)	This is a similar artificial hand as above for patients whose hand has been amputated below the elbow.
16	PTB BRACE (TIBIA BRACE)	Brace fabricated from HDPE to provide support to the lower limb from the ankle upwards.
17	FEMURAL SPLINT (THIGH)	Fabricated from HDPE with suitable fixings to provide support for the thigh.
18	AEROPLANE SPLINT	Fabricated from HDPE to provide support from wrist to shoulder to maintain right angle.
19	ELBOW SPLINT	Fabricated from HDPE to provide support to the elbow region.

GENERAL CONDITIONS OF CONTRACT

The work for providing appliances assistance by conducting camp shall be carried out as under :

- Assessment camp shall be conducted in 228 blocks of different district and corporation as shown in Section VI. The assessment of children attending the camp shall be done through qualified and experienced expert of respective field within three months from the date of work order and bidder have to supply the appliances for OH and HI within 45 days from the date of assessment camp. The expenditure for expert shall be borne by the bidder and expenditure for child will be borne by us.
- The qualified expert for assessment of OH/HI children under IED would be as under :
 - P&O Engineer or Orthopaedic Surgeon /Assistant for OH children.
 - Audiologist or RCI approved Educator having minimum 5 years experience.
- In addition of one team having expert stated above other five persons shall be included in the Team. The bidder shall appoint two or more team for assessment camp.
- The assistance shall be provided to children with OH & HI disability having age group between 6 to 18 years.
- The expert / team shall provide full guidance to disabled children & their guardians about the appliances.
- The bidder shall fill the form for registration with photograph of each child attending the camp and get it certified from IED Co-ordinators and BRC. The bidder shall arrange photographer for taking photograph at no extra cost.
- The programme for assessment camp shall be arranged with coordination with State IED Co-ordinator. If the bidder wishes to change the date of programme, he shall have to contact Sate OIC-IED within 15 days from the receipt of programme.
- The bidder shall be liable for penalty at the rate of Rs. 1000/ per day if he could not arrange the camp on the day specified for it.
- The client shall appoint 3rd party consultant for testing the appliances to be distributed in the camp. The bidder shall arrange for testing through appointed 3rd party consultant 2 or 3 days before distribution of appliances. If the appliances in the opinion of 3rd party consultant found not in accordance with specification, the same shall not be distributed to the children. The appliances approved by 3rd party consultant can only be distributed. If it is found that the bidder has distributed appliances having inferior quality, the payment shall be reduced to this extent and panel action including

blacklisting the bidder shall be taken. Delay arrangement of assesment camp and delay in distribution of appliances shall also constitute ground for panel action.

- If surgery is required to any child attending the camp, the bidder shall write details about the surgery in the form.
- The validity of the bid shall be 90 days only.
- The rate shall be applicable for one year from the date of award of tender. The time limit shall be reduced by State Project Director, SSA. The increase in time limit shall be decided with the concurrence of either party.
- Bids with incomplete information or not in accordance with instructions or without Bid security are liable to the rejected.
- The rates quoted by Bidder shall be inclusive of all the taxes & shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
